The School Board of Levy County met in regular session this 6th day of September, 2011 at 6:00 p.m., with Chairman Rick Turner, Paige Brookins, Cameron Asbell, Beth Davis, Robert Philpot and Board Attorney Sheree Lancaster present.

<u>Presentation – BES Beautification Project:</u> Cameron Asbell gave a PowerPoint presentation of the BES Beautification Project. He thanked the students from the Kountry Kids 4-H Club and Mrs. Bray's Ag Foundation Class from BMHS for all the work they did to improve the entrance to Bronson Elementary School. Also, he thanked the Sponsors and Volunteer Laborers.

<u>Public Hearing – Adoption of the Final 2011-2012 Millage and Budget:</u> Bob Clemons informed the Board that this was the second and final hearing of the two required public hearings to be held concerning the millage and budget for the 2011-2012 school year, stating that the purpose of the hearing was to adopt the final millage and final budget and to provide the public the opportunity to offer input. After further discussion, the Board took the following action. (See Supplemental Minutes)

<u>Comprehensive Student Progression Plan:</u> Patrick Wnek reviewed revisions to the Comprehensive Student Progression Plan for the 2011-2012 school year with the Board. After discussion, Beth Davis moved with seconded by Cameron Asbell to approve the 2011-2012 Comprehensive Student Progression Plan as presented. Motion carried.

<u>YTS Timber Sale / Bids:</u> Jeff Edison presented the Board with three recommendations from Tim Worley, Forester, Goethe State Forest, as follows:

- 1) Let this stand grow for a few more years. The current Basal Area averages about 60-80 square feet per acre. Basal Area is a measurement used to determine stand density or volume. Normally, he would recommend a thinning, if Basal Area is 90 or greater.
- 2) Seed tree harvest. Merchandizing the stand in such a fashion as to leave the best 10-11 trees per acre for a seed source will offset the need to utilize artificial regeneration.
- 3) Clearcut harvest. This is by far the most efficient means of harvesting and the Board would recoup a larger receipt but would incur greater costs in reforestation in the form of site preparation and seedling costs.

After discussion, Robert Philpot moved, seconded by and Cameron Asbell to accept the Superintendent's recommendation to rescind the resolution and adopt recommendation number one. Motion carried. School Board Attorney Sheree Lancaster said the Resolution declaring the timber on the tract of land at Yankeetown School as surplus property that was adopted by the Board at the August 16, 2011 Board meeting will need to be rescinded and she would do so at the September 20, 2011 Board meeting.

- a) General Fund Budget Summary Info for August 2011
- b) Permission to pay the Board of County Commissioners one half (1/2) the cost of redistricting Levy County precinct boundaries as required by Florida Statutes 101.001 and 101.71(2), by the end of the first year after the National Census has been taken.

Superintendent's Comments / Recommendations: Mr. Hastings stated he was very proud of our schools and employees and thanked everyone for a smooth open of the 2011-2012 school year. However, he said he wanted to briefly express his concern for declining revenues. His said according to our Finance report, our budget is five million dollars less than last year and with declining enrollment and FTE counts, we will lose additional money. He said his heart goes out to all educators of Levy County, the state and the nation. He said 90% of our rules and changes are mandated by the State Department of Education. He said the state is expanding the requirements without the proper means to follow through. He said all Levy County teachers and employees are working very hard to meet the state requirements and deadlines and we are in dire straits. Robert Philpot asked if we are looking for ways and other means to save money. Superintendent Hastings replied that we are exploring every way possible to save positions and have reduced bus routes to save fuel costs. Robert Philpot said the mandates of Tallahassee have increased the burden for everyone and we all have to work together to search for ways to save funds.

Board Comments: Robert Philpot commented that the Williston School campuses are looking good and thanked Ted Alexander and his crew for their hard work preparing them for school opening. He also thanked the county office people who manned the "Stuff the Bus" school buses over the weekend. He told Rob Ice that he has been hearing good things about Skyward, that things are better with it and it's getting more user friendly. Beth Davis mentioned the Foundations' Wild Beast Feast fundraiser, saying that her friend Jan will make the redfish chowder, charging \$125.00 for it. She said that breaks down to \$25.00 per board member. She said Mr. Philpot has volunteered to catch the redfish since Mr. Turner will not be able to. Cameron Asbell asked the Board to resolve that when bids are let for services, local businesses would be given precedence over other business that

may bid. After discussion, Board Attorney Lancaster said that would require a change in Board Policy. Bob Clemons stated that state statute would have to apply and that now consideration for local businesses over other businesses depends on both bids being equal. The School Board cannot choose a local business over another business if the bid is higher. All Board members agreed they would like to use local businesses as much as possible within the constraints of state law. Paige Brookins asked about the sale of old BHS to Levy County. Mr. Hastings said the deal was off, that Levy County did not want to pay what the School Board asked for the property. Paige said she thought the Stresing report was very thorough on the feasibility of the new WHS project, but asked if Special Facility funds were going to be available from the Sate to move forward? Bob Clemons stated that Special Facility funds were not available, but the Stresing report will posture the School Board to be ready when the funds become available, probably in 2-3 years, depending on the economy. Paige also said she encountered parents from Bronson at the CHS Football game who told her they were forced to raise money for BHS Graduation Ceremony at the Performing Arts Center because the School Board has mandated it. Mr. Hastings said the School Board has not mandated that graduation be held at the Performing Arts Center, that it is voted on by the Sr. Class where to hold graduation. Paige said the Value Adjustment Board has met. Beth Davis asked who the School Board's business person is and Paige said it is Brandi Horne. Beth then said she has been contacted by a parent from Chiefland about her daughter not having her dual enrollment text book. Jeff Edison explained that a trip was made to CFCC in Ocala to pick up the books and the bookstore was out of the English Textbook but would ship them to the school as soon as they are received.

There being no further business to come before the Board, meeting adjourned with the Board going into executive session for the purpose of negotiations discussion.
