REGULAR SESSION 9:00 a.m.

The School Board of Levy County met in Regular Session this 22nd day of May, 2018 at 9:00 a.m. with Board Chairman Cameron Asbell, Brad Etheridge, Rick Turner, Paige Brookins, Chris Cowart and Board Attorney David Delaney present.

Adoption of Agenda: Chris Cowart moved to approve the agenda, second by Brad Etheridge, motion carried.

<u>Welcome Visitors</u>: Board Chairman Cameron Asbell welcomed all the visitors and asked if anyone from the audience would like to address the Board. Sue Colson, Cedar Key resident expressed concerns with possible changes in the CKS Administration.

<u>Universal Design for Learning National Collaboration and "UPAR"</u>: Dr. Rosalind Hall introduced Gary Pearsey, from UPAR. He gave a PowerPoint presentation on Technical Assistance Paper Accessible Instructional Materials (AIM). He said all instructional materials, whether bound, unbound, hardback or softback textbooks, electronic content or media, or computer, etc., provided by schools to enable students to achieve grade-level standards in the core courses should be available in the formats needed by students with disabilities. He asked teachers Julie Gerhardt and Teresa Pender to update the Board on Snap-n-Read and how the program assists students with note taking and translation of other languages into English.

<u>Care Here Update</u>: Kalee Wade introduced Brian Branham, from CareHere. Mr. Branham gave a PowerPoint Presentation and update on the annual review of CareHere for the School Board of Levy County. He gave a comparison of four years, January 2014 through January 2018. He gave an overview of appointments, utilization, participation, diagnosis, HRA, prescriptions, costs, claims and workers' compensation. He said we had approximately \$554,475.00 estimated employee out-of-pocket savings because of approximately 10,148 medical visits to CareHere instead of outside facilities.

Designation of FSBA 2018-2019 Legislative Representative / Alternate: Superintendent Jeffery Edison informed the Board that this is the time to designate the 2018-2019 FSBA Legislative Representative and

Alternate. After discussion, Paige Brookins moved for Brad Etheridge to serve as the 2018-2019 FSBA Legislative and Chris Cowart as the Alternate, which remains the same as last year, second by Rick Turner, motion carried.
