## SPECIAL BOARD MEETING MINUTES

The School Board of Levy County met in Regular Session this 20<sup>th</sup> day of December, 2019 at 9:00 a.m. with Board Chairman Paige Brookins, Chris Cowart, Cameron Asbell, Ashley Clemenzi. Brad Etheridge and Board Attorney David Delaney present.

**Adoption of Agenda:** Chris Cowart moved to approve the agenda, second by Cameron Asbell, motion carried.

<u>Welcome Visitors</u>: Board Chairman Paige Brookins welcomed all the visitors and asked if anyone from the audience would like to address the Board. There were none.

Sale of the old Williston Middle School Property: Superintendent Jeff Edison said today's meeting was called because of corrections to paperwork for the sale of the old Williston Middle School property. He asked Board Attorney David Delaney to explain. David Delaney said in April 2018, SBLC the old WMS to the Levy Schools Foundation; however, the Title Insurance needed to be corrected for clarification and approved by the Board and the Levy County Finance Authorities. Board Member Chris Cowart requested to abstain from voting due to being a member of the Foundation. Blake Fugate, Attorney for the sale of the property, gave an overview of the revised documents and said the corrected documents needed to be approved and signed by the Board to release the property. After discussion of the Corrective Fee Simple Deed, Partial Release of Leases and Notice of Option, Exhibit A and the Resolution of the School Board of Levy County, Cameron Asbell moved to approve the revised documents for the sale of the old Williston Middle School property. Four Board member voted with one abstaining; therefore, the motion carried by 4 to 0 votes.
