Regular Session

The School Board of Levy County met in Regular Session this 5th day of November, 2020 at 9:00 a.m. with Board Chairman Paige Brookins, Chris Cowart, Cameron Asbell, Brad Etheridge and Board Attorney David Delaney present. Ashley Clemenzi was absent.

Welcome Visitors and Public Comments: Chairman Paige Brookins welcomed everyone to the meeting whether in person or virtually and asked if anyone would like to address the Board.
