The School Board of Levy County met in Executive Session this 10th day of November, 2015 at 5:40 p.m. with Board Chair Rick Turner, Paige Brookins, Chris Cowart, Cameron Asbell, Brad Etheridge and Board Attorney David Delaney present.

Expulsion Hearing: The Board heard information regarding a recommendation for expulsion. After the School Administrator and parent/guardians were sworn in by the Court Reporter and had given testimony, the following action was taken by the Board.

Student 16-04 (student and parents present): Chris Cowart moved with second by Paige Brookins to approve the recommendation of the Superintendent to expel the student for the remainder of the 2015/2016 SY and all of the 2016/2017 SY with the opportunity to attend the Levy Learning Academy and to receive anger management counseling while enrolled at LLA. The Superintendent also set a restitution amount of \$100.00 for the student to pay back to the school for damages caused to school property. Motion carried.
