REGULAR SESSION

The School Board of Levy County met in Regular Session this 9th day of May, 2017 at 9:00 a.m. with Board Chairman Chris Cowart, Cameron Asbell, Brad Etheridge, Rick Turner, Paige Brookins and Board Attorney David Delaney present.

<u>Adoption of Agenda:</u> After Board Chairman moved item D) VPK Update and Proposal, after E) School Presentation, Paige Brookins moved to approve the agenda, second by Brad Etheridge, motion carried.

<u>Welcome Visitors</u>: Board Chairman Chris Cowart welcomed all the visitors and asked if anyone from the audience who would like to address the Board. There were none.

School Presentation: YTS students, Amber Shear, 1st Grade, Abrielle Bailey, 2nd Grade, Abby Hopper 2nd Grade, Giovanna Burns, 4th Grade, and Madeline Rohrer, 5th Grade, shared their projects from the Science Fair with the Board, which covered biography, poetry, and research on trees. The Board thanked the students for their informative presentations and congratulated them on projects well done.

VPK Update and Proposal: Anna Kroll and Laura Klock updated the Board on the current and newly proposed Expanded Pre-K Program for the 2017-2018 SY. They said the current program is a half day, and the parents' fee is \$40.00 per week, but the new expanded program will be a full day and no parent fees for the Pre-K Program. After discussion, Brad Etheridge moved to approve the new Expanded Pre-K Program, second by Paige Brookins, motion carried.

UF Dual Enrollment Articulation Presentation: John Lott, Assistant Superintendent introduced Dr. Brian Marchman, Director of Distance and Continuing Education at UF and Andreas Vandenend, Assistant Director. Dr. Marchman and Mr. Vandenend gave a PowerPoint presentation and informed the Board about the enrollment criteria and registration procedures for students to Dual Enroll through UF. UF currently has students dual enrolled in Alachua, Orange, Osceola, Palm Beach and Broward counties. They want to expand DE to Levy, Pasco, Polk and Hillsborough counties for the 2017-2018 SY. They said students are hand selected due to the requirements and not all students are eligible for DE at UF. GPA must be 3.5, whereas other institutes require a 3.0 GPA. They must be 11th or 12th grade, test scores SAT: 1000, PSAT: 1030, or ACT: 21. After discussion, Rick Turner moved to approve to participate in DE through UF, second by Cameron Asbell, motion carried.

UF Athletic Trainer Services: John Lott, Assistant Superintendent introduced Kaitlyn Richter and Dr. Prine, from the UF Health Orthopaedics and Sports Medicine Institute. They gave an overview of their services and explained what Certified Athletic Trainers do at sporting events to assist the student athletes. They said it is very important that heat illness or concussions be properly detected early to prevent extensive health issues or emergencies with students, especially in the very hot summer months. Mr. Lott informed the Board that he has held meetings with the Principals and Athletic Directors and they all agree that having an Athletic Trainer at the sporting events would make everyone feel safer. Anna Kroll gave the Board a list of options showing the Athletic Costs for Options 1, 2, 3 and 4. After discussion, Brad Etheridge moved to approve Option 3, with the addition of Band Students and Cheerleaders, in support of hiring Athletic Trainers, second by Paige Brookins, motion carried.

<u>Risk Management Update:</u> Kalee Wade, Coordinator of Benefits and Risk Management, gave a Risk Management update for the 2016-2017 School Year. She said SBLC paid \$873,973.49 for the 2016-2017 SY for the following coverages: Property, Terrorism, Worker's Comp., Crime, Boiler & Machinery, TPA fee, NEFEC Budget, Errors & Omissions, Auto, Loss Fund (property, liability, worker's comp. & auto). For the 2017-2018 SY, the SBLC will pay \$833,191.70 for the same coverage, which is a reduction of \$40,781.79. She said we will receive a refund check of \$4,033.85 from the Loss Fund for the year 35. Mrs. Wade said SBLC will receive a refund check of \$147,546.55 from the Loss Fund Surplus for years 22, 24, and 25. Liability Insurance was

discussed. Board Attorney David Delaney said this coverage is very important for protection from hackers retrieving and stealing confidential information from employees and students.

Superintendent's Comments / Recommendations: Superintendent Jeffery R. Edison asked Mrs. Anna Kroll, Interim Director of Finance to introduce the new Director of Finance, Kimberly L. Lake. Mr. Edison asked Barb Rivers and Michael Homan to share the 3rd Grade Test Results with the Board. They said the State percentage achievement of Level 3 or above 3rd Grade ELA is 58%, and Levy County scored 53%, which is an achievement growth of 4% for Levy County Schools. Mr. Edison thanked everyone for attending graduations and other end-of-the-year events in support of all the schools.

Board Comments: Cameron Asbell shared a comment made by a Guidance Counselor during a 9th Grade Orientation: that a "C" was not a good grade and college would not be an option for them. He said we have experts in all areas of employment, which don't require a 4-year college degree or more. Those areas of expertise needed are auto mechanics, welders, plumbers, electrical, construction, heating and air, roofers, and too many others to name them all. He talked about the BMHS Football game being moved to Mayo to benefit a fundraiser for Taylor Valentine, age 21, and is very ill with cancer. He said the fundraiser from Bronson raised over \$2,000 and combined with Mayo's fundraiser, totaled over \$10,000 to aid Taylor with her funeral costs. Mr. Asbell said it's very sad that the media only wants to cover and publish negative news for SBLC and they disregard the good news, like the fundraiser for Taylor Valentine. He said they were invited to attend today's meeting, but they didn't attend. Rick Turner agreed with Mr. Asbell about the employment opportunities. He said in some areas welders can earn between \$21-\$80 per hour, working on pipelines, etc. Superintendent Edison said an Education Diploma only hangs in a frame on the wall; whereas, a certification of expertise allows people to perform jobs and tasks as a way of living and financial income. Paige Brookins thanked the Board Members for their information. She said she is very saddened to hear about Taylor's illness and her situation. Mrs. Brookins congratulated the CMHS girls' softball for their wins and the 2017 Graduates from all of the Levy County Schools. Board Chairman Chris Cowart congratulated the CKS Team for winning the walking challenge contest. He said they had a combined 2.1 and a half million steps. Mr. Cowart said he has heard good things about the Senior Walks through the schools. He said it's very good and inspiring for the other students to see the Seniors who are about to graduate from high school. Mr. Cowart said the amount of scholarship monies awarded this year was amazing and very much appreciated by the students and parents.

The BMHS / BES School visit was cancelled. There being no further business to come before the Board, the meeting was adjourned.
