The School Board of Levy County met in Regular Session this 26th day of March, 2019 at 9:00 a.m. with Board Chairman Brad Etheridge, Paige Brookins, Chris Cowart, Cameron Asbell, Ashley Clemenzi and Board Attorney David Delaney present.

CareHere Annual Update: Kalee Wade introduced Rick Hensley and Michelle Anglea from CareHere to give the annual update of the CareHere Center for the School Board of Levy County. Michelle said the partnership between CareHere and SBLC has been five years. She gave an overview of appointments, utilization, participation, diagnosis, HRA, prescriptions, costs, claims and workers' compensation savings by using the facility. She said we had approximately \$550,366.00 estimated employee out-of-pocket savings because of approximately 4,055 medical visits to CareHere instead of outside facilities.

Superintendent's Comments/Recommendations: Superintendent Jeffery Edison said he wants to hold a Board Workshop after the April 23, 2019 Board meeting to work on the Strategic Plan initiatives. He commended Gary Masters and his team for responding to a minor bus accident this morning at one of the elementary schools. He said no one was hurt in the incident. He reminded the Board about the Master Board training on Friday, March 29, 2019, from 8:30 - 4:30 at the BES Blue Room, and said lunch will be provided.

Board Comments: Cameron Asbell thanked Breezy and the Maintenance Department for taking care of the student drop off/pick up traffic route at one of the schools. He said the new traffic route is running very safely and well now. He talked about the students donating their proceeds to the little boy with cancer and thanked the District Office for their contributions and cards. Chris Cowart said the bill regarding accommodations for students with disabilities while testing will not be heard by DOE this year. Cameron Asbell said he is extremely disappointed with every manner this issue is being handled in Tallahassee. He said this issue is not just a Levy County problem. Chris Cowart said the normal cycle to try to get change to a bill is about three years, but he agrees that students with disabilities need accommodations during testing. Mr. Cowart thanked Breezy and Maintenance for completing the multi-court at CKS. He said the Cedar Key Arts Festival is this weekend. He said the Board purchased a hog from the Suwannee River Fair in support of YTS FFA, as well as support to other FFA students for their animals. Paige Brookins said Congressman Neil Dunn visited CMHS last week and talked with the students. Brad Etheridge said he enjoyed working with the Strategic Planning group for his section last Friday and looks forward to all the committees bringing

their plans together to develop the new Levy County Strategic Plan.

There being no further business to come before the Board, the meeting was adjourned for the Board to go visit BES and BMHS schools.
